By signing, I agree I understand that:

1. The District can pay only up to \$2,211.63 per student for tutoring services (2014-15 school year). Services will end for my student when that amount is reached. If I want my student to get services after that, I know I will have to pay for them myself.
2. My student must regularly attend the program. If he/she is absent more than three times (except for illness), my student may be dropped from the program.
3. Tutorial services will end on June 4, 2015, or when my student has used the amount allocated for his/her support, whichever comes first.
4. I am responsible for any transportation costs to and from the provider's location.
5. If I cancel the service with this provider during the current school year, I may not be allowed to select another provider until the next school year.
